GENERAL CHAPTER 2012 CONVOCATION OF MEMBERS

Circular 305 pointed out: "Each capitulant participates in this assembly on behalf of all the Brothers of the Congregation, not only on behalf of those of his Province or Vice- Province." The Rule of Life makes it clear: The General Chapter "represents all the Brothers and is the supreme collegial authority of the Congregation" (C 83).

What's more beautiful than this fellowship that should guide the work of this assembly called by the Lord. The Brothers participating in the Chapter are not delegates of a clan or party. They all belong to the Party of the Institute, if I may say so, committed to follow Christ by resembling him in his obedience to the Father, eager to be led by the fiery breath of the Spirit.

All the Brothers, and with them the Mennaisian Laity, will therefore have it at heart to accompany them with their fraternal prayer. This spirit of prayer that must abide in us will make us have an internal look illuminated by Hope and Love. The fruits of Chapter will not be measured by the amount of initiatives or the length of texts that will be written, but by the ardour of charity that will light up the Institute. For the path of the Spirit and that of the New Evangelization is the path of Love.

I therefore invite the Brothers, but also the Laity to pray a lot that we all have that burning Charity that will make us imitate Christ and let ourselves be guided by his Spirit, without fear or self-seeking. I renew the invitation I made in the previous Circular: let Christ change our look, let us ask the Holy Spirit to make us attentive to his inspirations; let us meditate the living Word of God; let us listen to the Brothers through whom God himself speaks to us, and let us perform with love acts that evangelize.

In Community, let us often recite the prayer for the Chapter, in whole or in part, in communion with the entire Mennaisian Family, remembering the words of Jesus: "I do not pray for these alone, but also for those who, through their word believe in me, so that all may be one. As you, Father, are in me and I in you, may they also be in us, so that the world may believe that You sent Me" (Jn 17: 20-21).

Let us build this great brotherhood, united in Christ. Thus the Holy Spirit, with the prayer of Mary, we will discern his call and respond with generosity and joy. It will also enable all the Brothers and all the Communities, to receive the orientations and decisions which will be made with a receptive heart and an ardent desire to see the Institute bearing new fruits for a new evangelization.
